Subject: <u>Frame Agreement for Supply of Optical Fiber Cables</u>

- 1. Sealed bids, in Pak Rupees on DDP-PKR/CFR/CPT-USD basis, are invited for Frame Agreement for Supply of Optical Fiber Cables in accordance with PTCL requirements/specifications.
- 2. Local and Foreign manufacturers of OFC are allowed to participate in tender themselves as bids submitted from agents or 3rd parties etc. shall not be considered by PTCL. Foreign manufacturers may involve a local partner to facilitate local activities/ services and PTCL may sign a tri-party agreement if desired by foreign manufacturer, however, POs shall be issued in the name of foreign manufacturer only.
- 3. The Frame Agreement shall be concluded on demand basis, whereby PTCL does not guarantee and is under no obligation to purchase/place orders for Supply of Optical Fiber Cables, until and unless there is a firm requirement of the same by PTCL. PTCL shall issue POs to the Offshore Supplier/ Contractor on need/demand basis from time to time under the Frame Agreement; the Frame Agreement shall be valid for a period of three (03) years, starting from the date of signing of Frame Agreement by all the parties. Furthermore, PTCL reserves the right to revise entire terms and conditions of the Frame Agreement Annually, effective from the date of signing of the Frame Agreement and during its validity; in case of any revision(s) in price and/or other provisions, the same shall be applicable to all the POs to be issued by PTCL during the next/coming 12 months (within the validity of the Contract) OR remainder of the Frame Agreement validity, whichever is applicable/decided by PTCL.

Bids (marked as "Frame Agreement for Supply of Optical Fiber Cables", RFP/RFQ # PROC. 1 3-2/2/201020/2465 complete in all aspects and as per procedures laid down in the RFP/RFQ shall be submitted to the undersigned by **17.12.2020 before 1200 hours.**

- 4. Bids must be accompanied by bid bond/security of 1,000,000/- Rupees as per relevant clause(s). <u>In case of non-</u> compliance, the bids will be disqualified from further processing.
- 5. Bids received after the above deadline shall not be accepted and be returned unopened.
- 6. Vendor registration is mandatory for all the vendors interested to supply materials/services to PTCL. It is essential to mention the Vendor Registration Code (VR Code) assigned by PTCL on Quotation/Bids submitted by Bidder(s). Unregistered vendors are required to get registered with PTCL for good/continuous business relationship.
