- 4. Soft/Electronic copies of bids shall be uploaded via web portal eProcurement and hard copies shall be submitted in the office of undersigned as per instructions provided in Tender Documents on or before 12:00 Hours on August 31, 2018.
- 5. Commercial bids must be accompanied by a bid security of two percent (2%) of the total value of the quoted price and undertaking confirming the same must be part of Technical Bids. In case of non-compliance, the bids will be disqualified from further processing.
- 6. Bids received after the above deadline shall not be accepted and be returned unopened. Bids through Email/Fax shall not be accepted.
- 7. PTCL reserves the right to reject bids and to annul the bidding process at any time, without thereby incurring any liability to the affected bidder or any obligations to inform the affected bidder of the grounds for PTCL action.
