- Sealed bids are invited from manufacturers/OEM or their reputed & authorized firms/dealers/suppliers on DDP-PKR/CPT-US\$ basis (for foreign portion on CFR/CPT-US\$ basis while local portion on DDP-PKR basis inclusive of all applicable taxes & duties) for the Frame Agreement for SITC of 100K GPON OLT Lines and supply of 100k GPON ONTs in accordance with PTCL requirement/Technical Specifications.

The Frame Agreement shall be concluded on demand basis, whereby PTCL does not guarantee and is under no obligation to purchase/place orders for 100K GPON OLT Lines and supply GPON ONTs, until and unless there is a firm requirement of the same by PTCL. The Frame Agreement shall be valid for a period of Two (02) Years.
- 3. Soft/Electronic copies of bids shall be uploaded via web portal eProcurement and hard copies shall be submitted in the office of undersigned as per instructions provided in Tender Documents on or before 12:00 Hours on June 07, 2018.
- 4. Tender documents can be purchased from the undersigned on payment of **Rs. 2500**/- (non-refundable) through Demand Draft/pay order in favor of Pakistan Telecommunication Company Limited, H/Qs G-8/4, and Islamabad.
- 5. Commercial bids must be accompanied by a Bid Bond (as Bid Security) in the name of Pakistan Telecommunication Company Limited HQ, Islamabad equivalent to **PKR 2,000,000/-** (Pak Rupees Two Million only), issued by a first class/scheduled bank located in Pakistan. **In case of non-compliance, the bids will be disqualified from further processing.**
- 6. Bids received after the above deadline shall not be accepted and be returned unopened. Bids through Email/Fax/Courier shall not be accepted.
- 7. PTCL reserves the right to reject bids and to annul the bidding process at any time, without thereby incurring any liability to the affected bidder or any obligations to inform the affected bidder of the grounds for PTCL action.
