The Contract shall be valid for a period of Three (03) Years.

Bids (marked as "Frame Agreement for Consultancy Services for Telecom Towers Stability Assessments, Dismantling and Report on Design & Strength "RFP # Proc.1-1/2/260919/2211" complete in all aspects and as per procedures laid down in the RFP) shall be submitted latest by **25-10-2019 before 1200 hours.**

Bids must be accompanied by Bank Guarantee (as bid security) in the name of Pakistan Telecommunication Company Limited HQ, Islamabad equivalent to PKR 100,000 valid for a period of 06 Months from the date of its issuance, issued by a first class/scheduled bank located in Pakistan. In case of non-compliance, the bids will be disqualified from further processing.
