Subject: Frame Contract for IP based transport solution on Turnkey Basis

- For requirement of Frame Contract for IP based transport solution on Turnkey Basis, bids are required on CFR/CPT-USD and/or DDP-PKR basis from all leading IP/PTN OEMs/partners with field proven experience in PTCL's IP/Transport network. OEMs will be allowed to either participate directly or through a single partner.
- Bids with Bid Security of PKR 3,000,000 (Three Million) shall be submitted to PTCL Headquarters, Islamabad as per instructions to the bidders contained in the Bid Documents by on 08 February 2022 (before 1200 Hours) positively. In case of non-compliance, the bids will be disqualified from further processing. Bid(s) received after the above deadline shall not be accepted at all.
- 3. Bids will be submitted in soft form in accordance with PTCL requirements/specifications.
- 4. Due to prevailing situation in the country, online bids mission is allowed by PTCL as per following instructions:
 - a. Submit separate password protected technical bid and commercial bid in excel or pdf format through email i.e. "bidsubmission@ptcl.net.pk" before the deadline <u>8th February 2022 (before 1200 hours)</u>. Bids submitted after due time and on other e-mail address shall not be considered.
 - b. Separate passwords for technical bid and commercial bid shall be shared with Manager (Purchase Finance-Business Sup.) and Group Head (Purchase Finance & Contracts) only through email i.e. "Babar.Ali@ptclgroup.com" & "khalid.imran@ptclgroup.com" before bids submission deadline <u>8th</u> <u>February 2022 (before 1200 hours)</u>.
 - c. Bid Bond submission is mandatory. Soft copy (scan) of the bid bond shall be accompanied with bids whereas hard copy (original) in sealed envelope shall be submitted to the office of G.M. Procurement (Business Support). Technical bid must have "bid bond confirmation" that the original bid bond instrument is enclosed in commercial bid. Non-submission of Bid Bond may lead to rejection of bid from the tender.
 - d. Complete tender number with description must be mentioned in e-mail subject for submission of bids.
- 5. It is to further clarify with emphasis that any bids/ offers coupled with any conditions contrary to RFP requirement and any bids submitted unsolicited during the entire course of tendering shall not be accepted, at all.
- Bidder shall submit/share their technical queries till <u>28th January 2022</u>, no query will be entertained after elapse of said date.
- 7. PTCL reserves the right to reject any or all bids and to annul the bidding process at any time, without thereby incurring any liability to the affected bidder(s) or any obligations to inform the affected bidder(s) of the grounds for PTCL Action.
- 8. Compliance to PTCL standard payments terms and delivery period, given in tender documents is mandatory for participation in the bid.
- Bidder must mention their Vendor Registration code on offer. In case vendor is not registered, then registration must be done before the issuance of Letter of Award/Intent. Vendor Registration form can be downloaded from PTCL website.
