Bids must be received duly completed in all respects. Documents can be purchased from undersigned on payment of PKR 1000/- (non-refundable) through Demand Draft/Pay Order in favor Senior Manager (Accounts and Payments) ITR/RTR, Islamabad before bid closing date.
2. Separate Technical and Commercial bids required to be submitted up to **5<sup>th</sup> of August, 2020** in the **Tender Box** placed at the Reception of PTCL Zonal Office, F-5/1, Islamabad.
3. Bids should be marked as
  - a) “Technical Bid for Unit based frame contract for supply & services of ISP & ISP Corporate in all regions of North Zone”.
  - b) “Commercial Bid Unit based frame contract for supply & services of ISP & ISP Corporate in all regions of North Zone”.
4. The Bids must be accompanied by an amount of **Rs. 100,000/-** as security in the form of CDR / DD in the name of **“SM (Accounts & Payments) PTCL Islamabad”**.
5. Bids received after the above deadline shall not be accepted and will be returned unopened.
6. PTCL reserves the right to reject any or all bids and to annul the bidding process at any time, without thereby incurring any liability to the affected bidder (s) or any obligations to inform the affected bidder (s) of the grounds for PTCL action.
7. Vendor registration is mandatory for all the vendors interested to engage in business with PTCL. Unregistered vendors would be required to get registered with PTCL for this purpose before award of work.
