Bids with bid security of 2% quoted rates (Including 16% SST) should be submitted/ dropped in bid box, at main reception PTCL House F-5/1, Islamabad as per instructions to the bidders, contained in the Bid Documents/RFP by 11:30 Am on 23-10-2019 positively. In case of non-compliance, the bids will be disqualified from further processing. Bid(s) received after the above deadline shall not be accepted.
- 3. Tender documents shall be provided till 1st October 2019.
- 4. This project will be on turnkey basis and bidders will provide end to end solution. All bidders shall be invited for pre bid conference chaired by Project Director to explain the project conception. This date shall be communicated to all those who purchase the tender document by the above mentioned date.
- 5. After the initial conference bidders shall be provided 10 days for visiting below mentioned sites (Between 1000 hrs 1500 hrs), to carry out the load calculations and after thorough costing, submit the proposals by the deadline:

  - b. PTCL F-8 Exchange
  - c. PTCL House F-5/1 Islamabad
  - d. PTCL Complex Satellite Town Rawalpindi

- 8. After the presentations and changes (If any), bidders shall submit their detailed bids latest by 23<sup>rd</sup> October 2019.
- 9. PTCL reserves the right to reject any or all bids and to annul the bidding process at any time, without thereby incurring any liability to the affected bidder (s) or any obligations to inform the affected bidder(s) of the grounds for PTCL Action.
- 10. Compliance of PTCL standard payments terms and delivery period, given in tender documents is mandatory for participation in bid. Successful bidder after award of work

- will ensure pictures are taken before execution, during execution and after completion of work.
- 11. Bidder must mention their Vendor Registration code on offer. In case vendor is not registered, then registration must be done before the issuance of Letter of Intent/Award (LOI/LOA).

Incomplete/partial bids will not be entertained and the bidder will be disqualified without any further notice.
