Sealed bids, in Pak Rupees on DDP basis (inclusive of all applicable taxes) are invited from Manufacturers or their authorized Representatives/Dealers for Supply, Installation, Testing and Commissioning of Rectifier System. The Frame Contract/Agreement shall be concluded on demand basis, whereby PTCL does not guarantee and is under no obligation to purchase/place orders for Rectifier Units, until and unless there is a firm requirement of the same by PTCL. The Contract shall be valid for a period of Three (03) Years.
- 3. Bids (marked as "Supply, Installation, Testing and Commissioning of Rectifier System "RFP # PROC.3-1/2/300818/1993" complete in all aspects and as per procedures laid down in the RFP) shall be submitted latest by **09.10.2018 before 1200 hours.**
- 4. Bids must be accompanied by Bank Guarantee/Call Deposit "CDR" (as bid security) in the name of Pakistan Telecommunication Company Limited HQ, Islamabad equivalent to PKR 500,000 valid for a period of 06 Months from the date of its issuance, issued by a first class/scheduled bank located in Pakistan. <u>In case of non-compliance</u>, the bids will be disqualified from further processing.
- 5. Bids received after the above deadline shall not be accepted and be returned unopened. Bids through Email/Fax shall not be accepted.
