Frame Agreement for Supply of PSTN Telephone Sets (Corded & Cordless)

- (a) Sealed Bids in Pakistani Rupees (PKR) on DDP basis (inclusive of all applicable taxes) and (USD) on CPT/CFR Basis are invited from OEM's or Authorized Distributors with valid Manufacturer Authorization Letter (MAL) only for the PSTN Telephone Sets (Corded & Cordless) on supply basis to PTCL on frame contract model and in accordance with PTCL requirements and Scope of Work ("SOW").
- (b) Bids (marked as "**RFQ # PROC.3-2/2/010126/4509 – Supply of PSTN Telephone Sets (Corded & Cordless) Frame Contract Model**") complete in all aspects and as per procedures laid down in the RFQ) shall be submitted latest by **04th February 2026 before 1200 hours**.
- (c) Bids must be accompanied by Bank Guarantee/Call Deposit "CDR" (as bid security) in the name of Pakistan Telecommunication Company Limited – HQ, Islamabad equivalent to Pakistani Rupees Three Hundred Thousand Only (PKR 0.3 Million) valid for a period of six (06) Months from the date of its issuance, issued by a first class/scheduled bank located in Pakistan. In case of non-compliance, the Bids will be disqualified from further processing.
- (d) Bids received after the above deadline shall not be accepted and be returned.
