## Subject: Frame Agreement for Supply of Refurbished GPON ONTs

- 1. Bids on DDP-PKR or CFR/CPT-USD basis are invited to sign Frame Agreement(s) for Supply of Refurbished GPON ONTs in accordance with PTCL requirements/specifications.
- 2. The Frame Agreement shall be concluded on demand basis, whereby PTCL does not guarantee and is under no obligation to purchase/place orders for Supply of Refurbished GPON ONTs, until and unless there is a firm requirement of the same by PTCL. PTCL shall issue POs to the Contractor/ Manufacturer on need/demand basis from time to time under the Frame Agreement; the Frame Agreement shall be valid for a period of three (03) years, starting from the date of signing of Frame Agreement by all the parties. Furthermore, PTCL reserves the right to revise entire terms and conditions of the Frame Agreement Annually, effective from the date of signing of the Frame Agreement and during its validity; Prices may be renegotiated for every order depending upon quality and quantity of lot available with shortlisted bidders.
- 3. Online bids submission is allowed by PTCL as per following instructions:
  - a. Submit separate password protected technical bid and commercial bid in excel or pdf format through email i.e. <a href="mailto:bidsubmission@ptclgroup.com">bidsubmission@ptclgroup.com</a> before the deadline 15<sup>th</sup> January, 2023 (before 1200 hours). Bids submitted after due time and on other e-mail address shall not be considered.
  - b. Separate passwords for technical bid and commercial bid shall be shared with Group Head (Purchase Finance & Contracts) through email i.e. <a href="M.Azhar@ptclgroup.com">M.Azhar@ptclgroup.com</a> before bids submission deadline.
  - c. Complete tender number with description must be mention in e-mail subject for submission of bids.
- 4. Bids received after the above deadline shall not be accepted and be returned unopened.
- 5. Bid Bond submission of 25,000/- Rupees as per relevant clause(s) is mandatory. Soft copy (scan) of the bid bond shall be accompanied with bids whereas hard copy (original) in sealed envelope shall be submitted to the office of G.M. Procurement (Business Support). Non-submission of Bid Bond may lead to rejection of bid from the tender.
- 6. Complete tender number with description must be mentioned in e-mail subject for submission of bids.
