Re-Construction of Boundary wall and its closing protection of Dera Murad Jamali Exch QTR

1. Sealed bids, in Pak Rupees on DDP basis, are invited for Re-Construction of Boundary wall and its closing protection of Dera Murad Jamali Exch of Quetta Telecom Region (QTR) for the year 2024 in accordance with PTCL requirements/ specifications.
2. Bids (marked as “RFP # R-PROC. – 6-2024/6009” complete in all aspects and as per procedures laid down in the Tender) shall be submitted latest by **22-April-2024** before 12:00 hours, to the office of Manager Regional Procurement QTR Mir Jaffar Khan Jamali Road Quetta.
3. The Bids should contain Rs. 50,000/- bid security in the form of CDR / DD in the name of “[Pakistan Telecommunication Company Limited](#)”. In case of non-compliance, the bids will be disqualified from further processing.
4. Bids should be marked as:

 - b. “Commercial Bid for Tender NO. R-PROC. 6-2024/6009”.
5. Tender documents can be purchased from the Office of Manager Regional Procurement QTR Mir Jaffar Khan Jamali Road Quetta not later than **21-April-2024** (*last date of Form Purchase*). Payment for the tender document is PKR. 1000/- (non-refundable) through Cash/Demand Draft/pay order, in favor of [Pakistan Telecommunication Company Limited](#).

It is essential to mention the Vendor Registration Code (VR Code), assigned by PTCL, on Quotation/Bids submitted by the Bidder(s).
