- Bids with Bid Security of PKR 500,000 (0.5 million) shall be submitted to PTCL Headquarters, Islamabad as per instructions to the bidders contained in the Bid Documents by on Monday 30thMay 2022 (before 1200 Hours) positively. In case of non-compliance, the bids will be disqualified from further processing. Bid(s) received after the above deadline shall not be accepted at all.
- 3. Due to prevailing situation in the country, online bids mission is allowed by PTCL as per following instructions:
 - a. Submit separate password protected technical bid and commercial bid in excel or pdf format through email i.e., <u>bidsubmission@ptcl.net.pk</u> before the deadline Monday 30th May 2022 (before 1200 hours). Bids submitted after due time and on other e-mail address shall not be considered.
 - b. Separate passwords for technical bid and commercial bid shall be shared with Head of Contracts Financial Evaluation & SM Finance Business Partner (Group IT)/PTCL only through email i.e., khalid.imran@ptclgroup.com & m.azhar@ptclgroup.com before bids submission deadline.
 - c. Bid Bond submission is mandatory. Soft copy (scan) of the bid bond shall be accompanied with bids whereas hard copy (original) in sealed envelope shall be submitted to the office of Head of Procurement Support. Non-submission of Bid Bond may lead to rejection of bid from the tender.
 - d. Complete tender number with description must be mentioned in e-mail subject for submission of bids.
