

## TENDER NOTICE

### REGIONAL FRAME AGREEMENT SUPPLY, INSTALLATION & MAINTENANCE OF ITEMS USED IN ROUTINE OFFICE BUILDINGS IN HYTR, STR & QTR REGIONS – PTCL BUSINESS ZONE SOUTH-II

1. Sealed bids are invited from potential bidders with relevant experience to develop unit-based frame rates for the **SUPPLY, INSTALLATION & MAINTENANCE OF ITEMS USED IN ROUTINE OFFICE BUILDINGS IN HYTR, STR & QTR REGIONS – PTCL BUSINESS ZONE SOUTH-II**.
2. Regional framework contracts will be signed with successful bidders after a competitive bidding process for a period of Three (03) years from contract signing date. The frame contract shall be concluded on demand basis, whereby PTCL does not guarantee and is under no obligation to purchase/place orders for until and unless there is a firm requirement of the same by PTCL. PTCL shall issue Purchase Order(s) to the contracted vendor on need/demand basis from time to time in duration of the contract.
3. Tender documents can be Obtained from **Office of Manager (Regional Procurement) HyTR/STR**, PTCL Region Office, Near Gul Center Hyderabad and **Manager (Regional Procurement) QTR**, PTCL Region Office, Mir Jaffer Khan Jamali Road Quetta not later than **12 December 2024** (last date of Form Purchase).
4. Bids shall be submitted on or before **18 December 2024**. Separate Technical and Commercial bids required to be submitted, as instructed in in the tender documents.
5. Bids should be marked as:
  - “Technical Bid for Tender NO. R-PROC.6-2024/6031”.
  - “Commercial Bid for Tender NO. R-PROC.6-2024/6031”.
  - “Bid Bond for Tender NO. R-PROC.6-2024/6031”.
6. Bids received after the above deadline shall not be accepted and will be returned unopened.
7. The Bids must be accompanied by a Bid bond of PKR **100,000/-** as security in the form of CDR / DD in the name of “**Pakistan Telecommunication Company Limited**”.
8. PTCL reserves the right to reject any or all bids and to annul the bidding process at any time, without thereby incurring any liability to the affected bidder (s) or any obligations to inform the affected bidder (s) of the grounds for PTCL action.
9. All the rates must be inclusive of all taxes except GST.
10. Vendor registration is mandatory for all vendors interested in supplying materials/services to PTCL. It is essential to mention the Vendor Registration Code (VR Code), assigned by PTCL, on Quotation/Bids submitted by the Bidder(s).
