1. Sealed bids, in Pak Rupees on DDP basis, are invited for **R&M 50 KVA DG set at DMJ and 05 KVA PGs in Sibi domain** - Quetta Telecom Region at QTR of for the year 2025 in accordance with PTCL requirements/ specifications.
